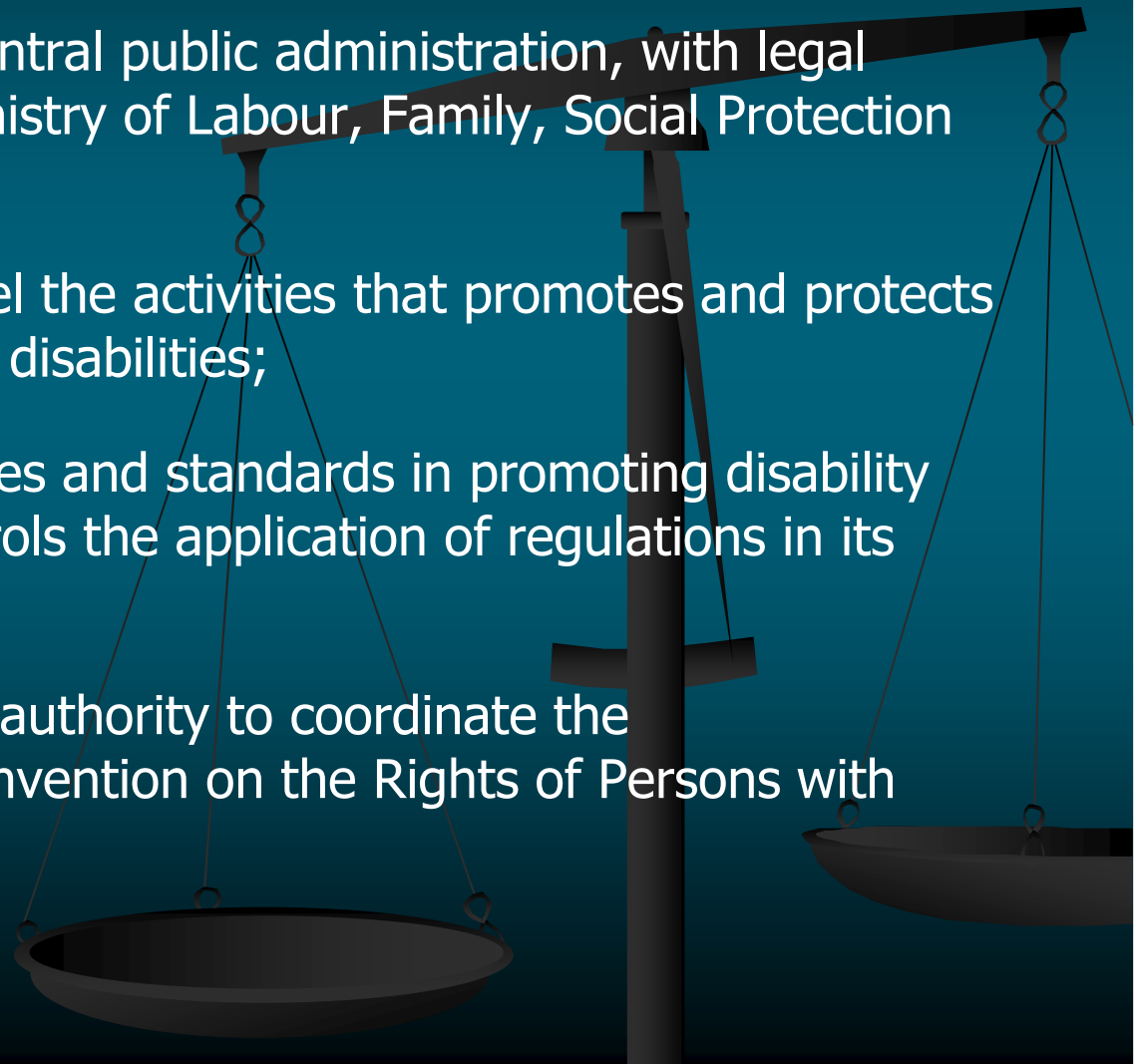

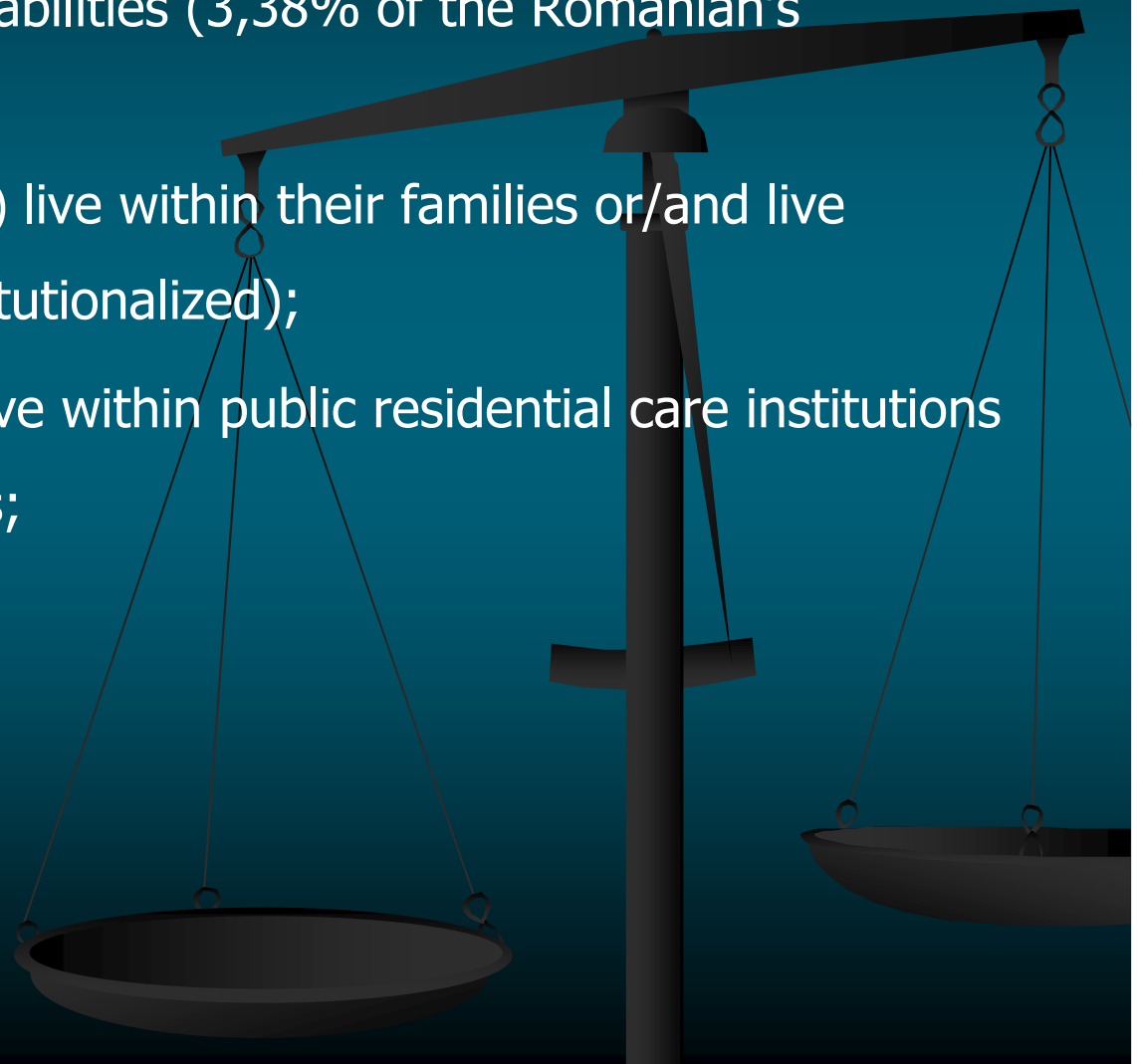
G.D. no. 86/2014 , G.D. no. 50/2015

- specialized body of the central public administration, with legal personality, under the Ministry of Labour, Family, Social Protection and Elderly;
- coordinates at central level the activities that promotes and protects the rights of persons with disabilities;
- develops policies, strategies and standards in promoting disability rights, monitors and controls the application of regulations in its field;
- designated as the central authority to coordinate the implementation of the Convention on the Rights of Persons with Disabilities;



The protection system for persons with disabilities – statistical data

- 766.153 persons with disabilities (3,38% of the Romanian's population);
- 97,7% (748.309 persons) live within their families or/and live independently, (non-institutionalized);
2,3% (17.844 persons) live within public residential care institutions for adults with disabilities;
- 47% rural areas;
- 53% urban areas;
- 46% men;
- 54% women.



Social services

- **429** – number of public care institutions for adults with disabilities

372 residential (17.844 beneficiaries)

- 30,66% care and assistance centers (36.69% beneficiaries);

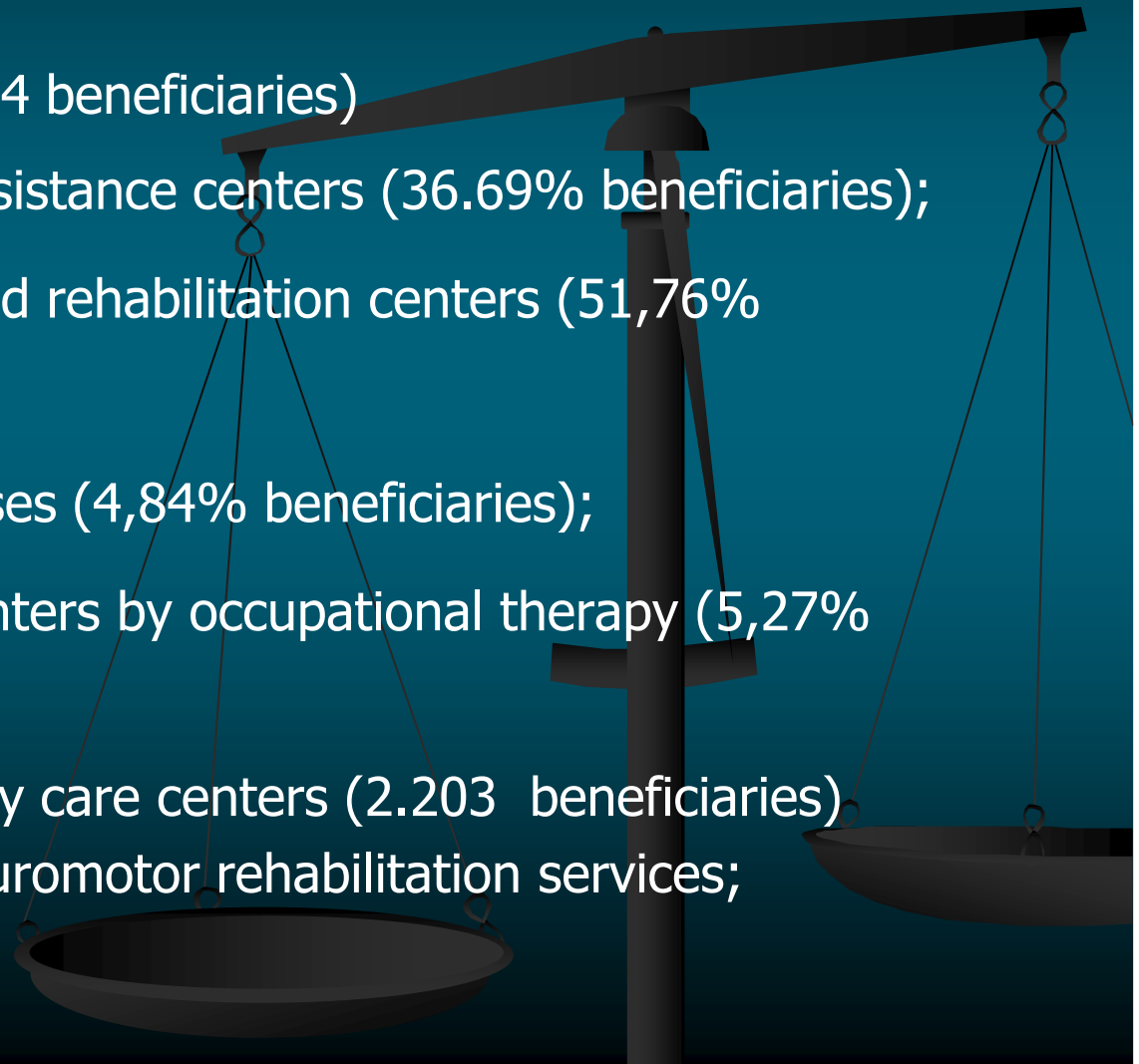
- 33,43% recovery and rehabilitation centers (51,76% beneficiaries);

- 27,63% shelter houses (4,84% beneficiaries);

- 4,7% integration centers by occupational therapy (5,27% beneficiaries);

57 non -residential/day care centers (2.203 beneficiaries)

- 50% ambulatory neuromotor rehabilitation services;

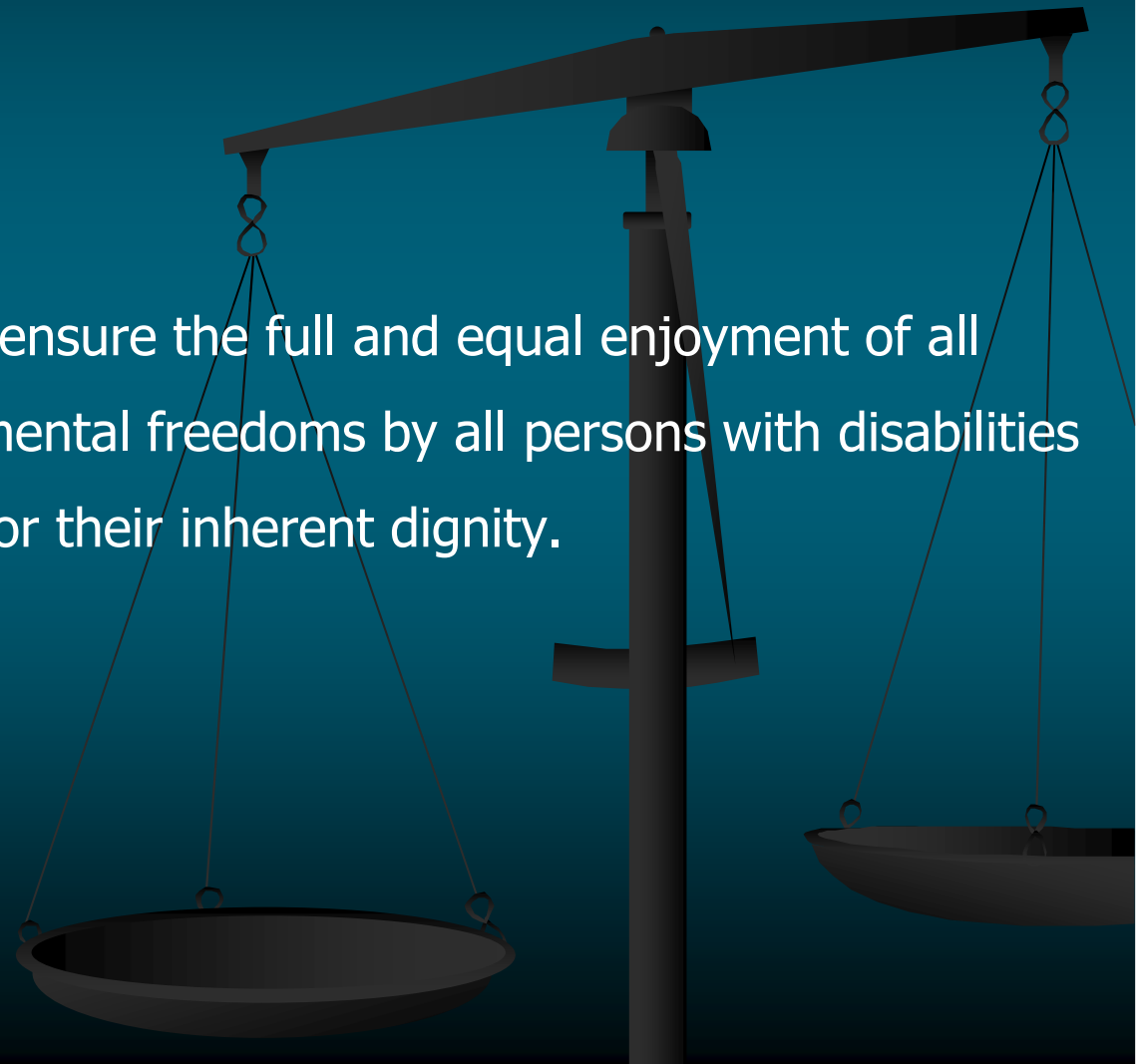

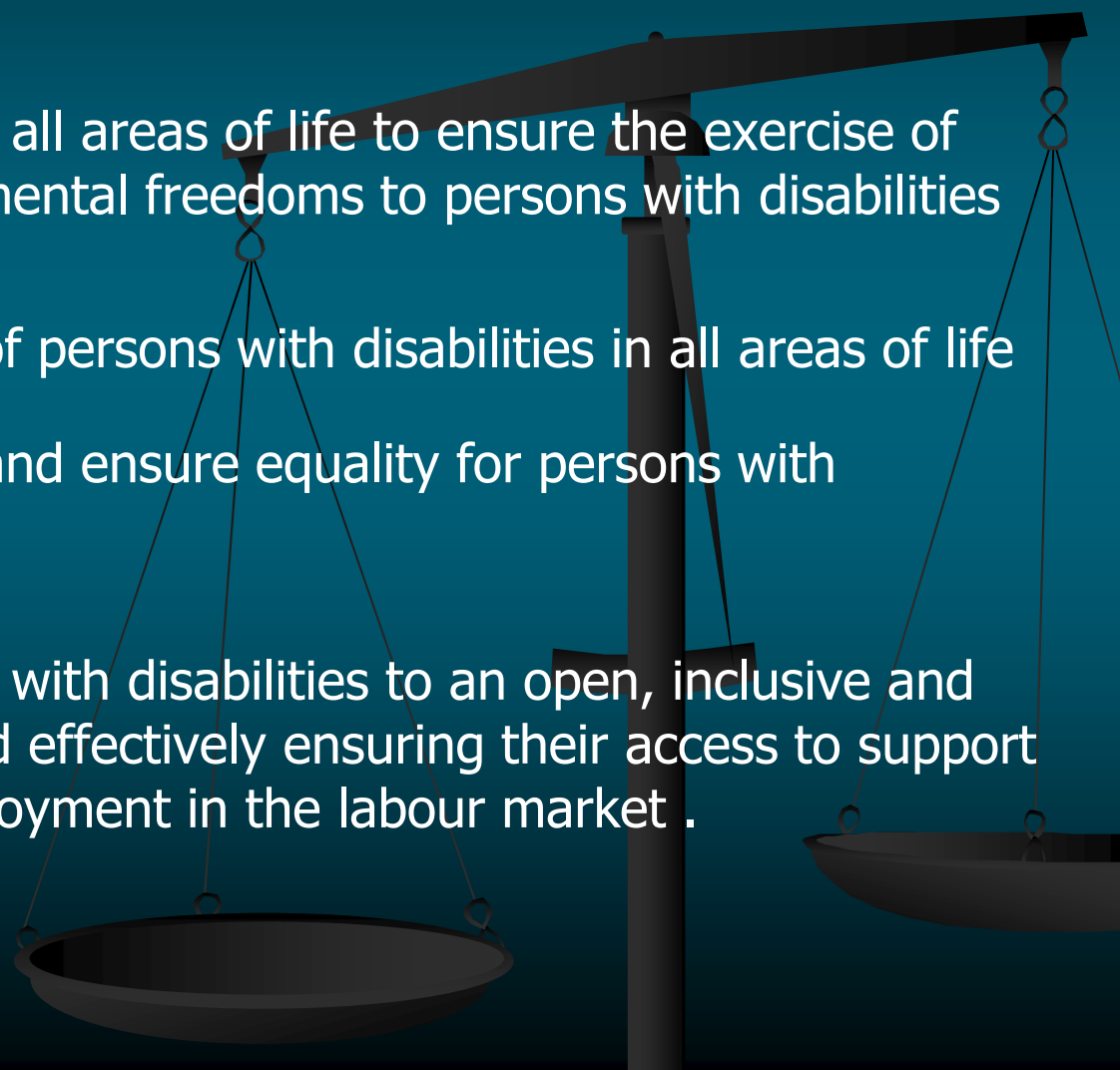

- Ensure access of persons with disabilities to an open, inclusive and accessible work place and effectively ensuring their access to support services to increase employment in the labour market .



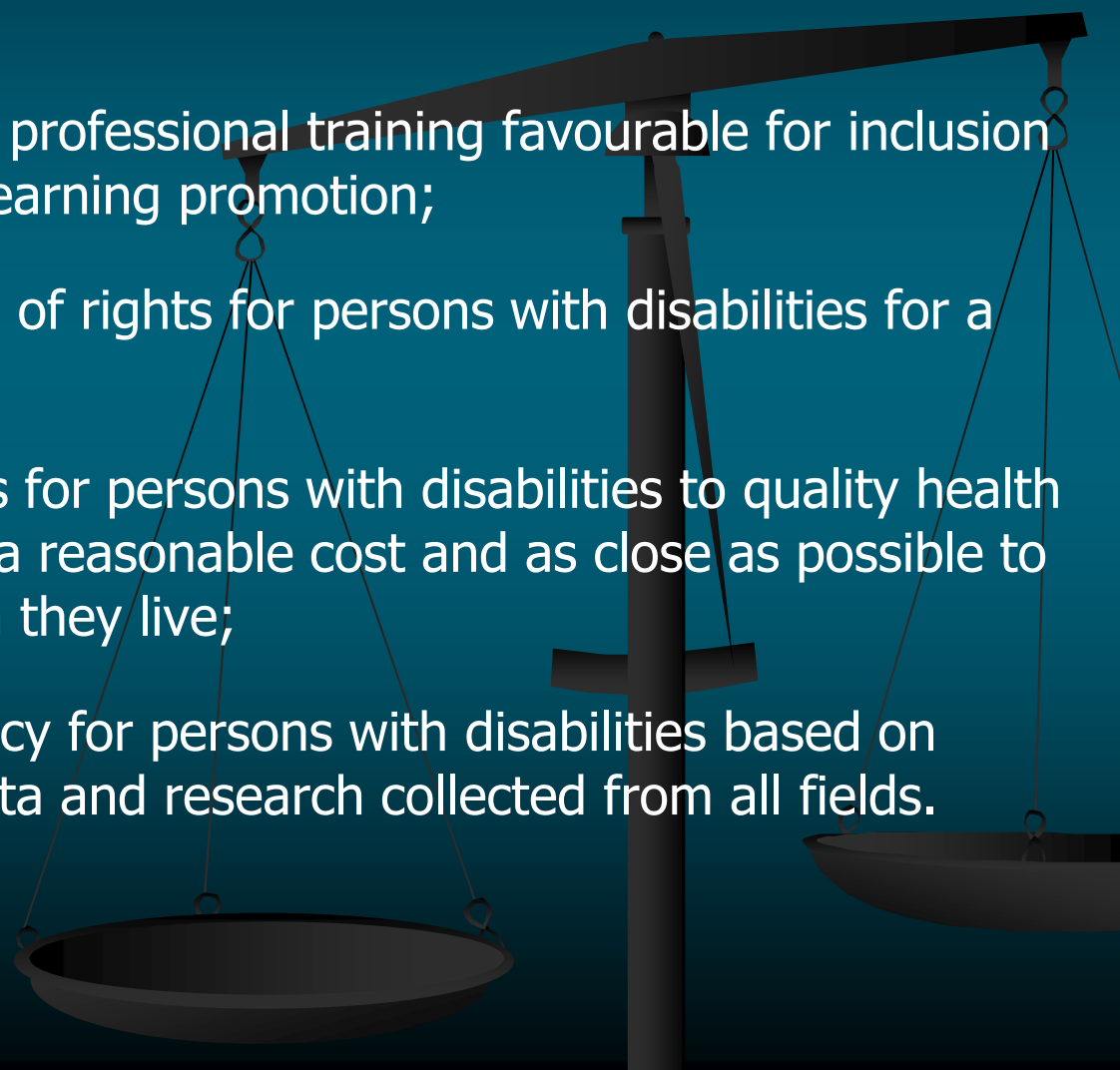

General Objectives :

- Promoting education and professional training favourable for inclusion at all levels and lifelong learning promotion;
- Promotion and protection of rights for persons with disabilities for a decent life conditions;
- Ensuring equitable access for persons with disabilities to quality health services and facilities, at a reasonable cost and as close as possible to the communities in which they live;
- The substantiation of policy for persons with disabilities based on information, statistical data and research collected from all fields.



Main outcomes:

- increasing the accessibility of the physical environment, transport, information and media;
 - ensuring and promoting conditions for the full exercise of rights and freedoms by all persons with disabilities on an equal basis as the other members of society;

 - social services and support services within the community, including the development of an integrated, inclusive, accessible and quality services;
 - quality health services and facilities, at a reasonable cost and as close as possible to the communities in which they live;
 - strengthening the coordination, monitoring and evaluation mechanisms.

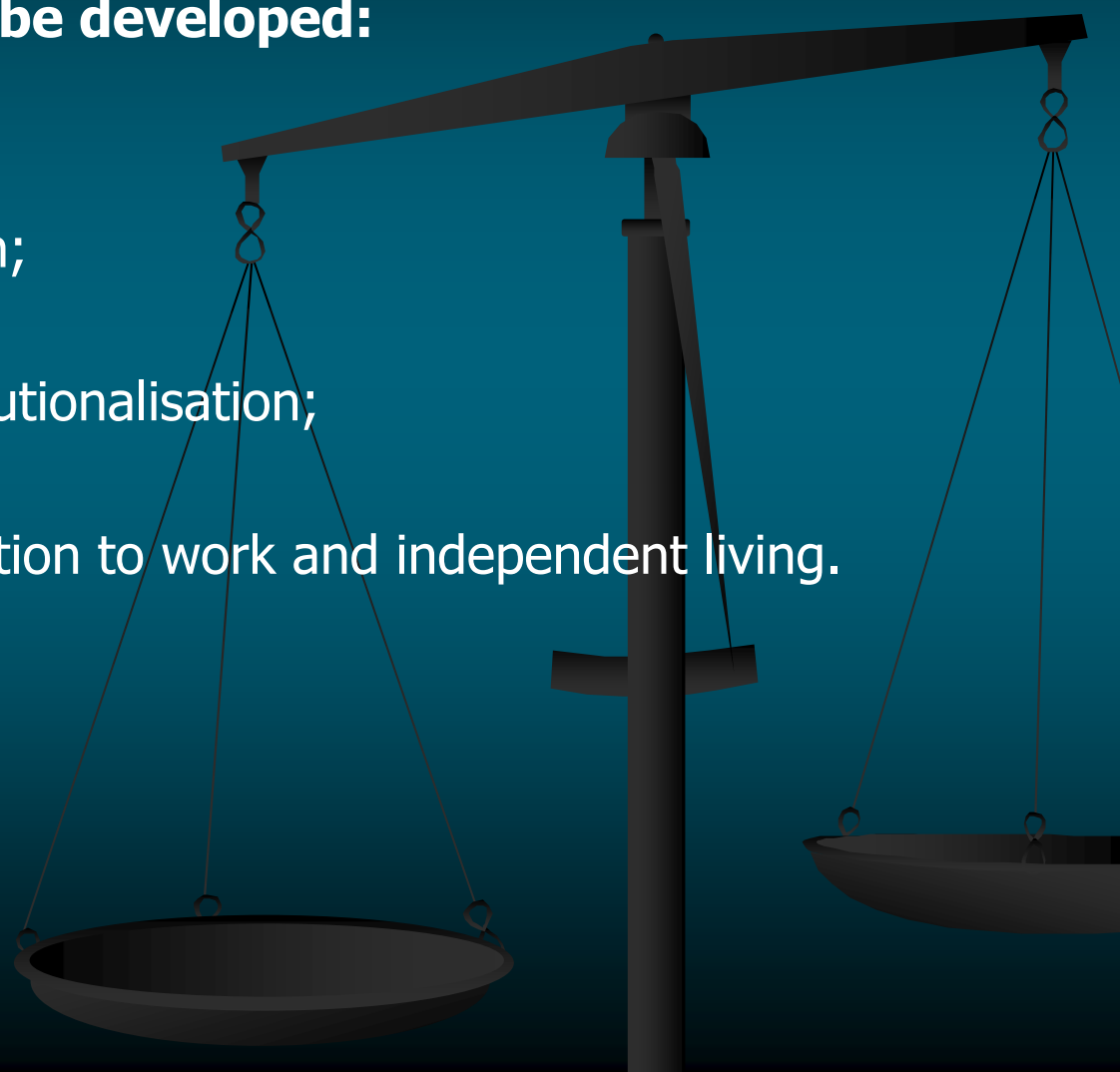
