



CRITERIA FOR CASH SOCIAL ASSISTANCE ARTICLE 8 OF THE LAW (8 PARAGRAPHS AND 17 SUBPARAGRAPHS)

- AVERAGE MONTHLY INCOME OF A SINGLE RESIDENT OR COHABITANTS MUST BE LOWER THAN STATE SUPPORTED INCOME (EUR 122) PER PERSON (FAMILY MEMBER) AND THE VALUE OF THE PROPERTY OWNED MUST NOT EXCEED THE RATIO OF THE PROPERTY VALUE ESTABLISHED);
- IF A PERSON IS UNEMPLOYED, HE OR SHE MUST REGISTER WITH THE LABOUR EXCHANGE (HEREINAFTER REFERRED TO AS THE LE);
- IF A PERSON IS EMPLOYED, HIS OR HER WAGES MUST BE NOT LOWER THAN 2/3 OF THE MINIMUM MONTHLY WAGE;
- PERSONS WHO REACHED THE RETIREMENT AGE, THE DISABLED OR PERSONS ENTITLED TO ANY TYPE OF PENSION;
- DISABLED PERSONS WITH 45-55% CAPACITY FOR WORK MUST REGISTER WITH THE LE.

OTHER CRITERIA ENTITLING TO BENEFIT

- A PERSON RECEIVING TREATMENT IN AN INPATIENT HEALTH CARE INSTITUTION OR ON AN OUTPATIENT BASIS FOR MORE THAN ONE MONTH;
- A PERSON IS RAISING A CHILD UNDER 3 YEARS OF AGE;
- ONE OF COHABITANTS TAKES CARE OF OR NURSES A PERSON, A CHILD WITH REGARD TO WHOM THE NEED FOR PERMANENT CARE (ASSISTANCE) OR NURSING WAS ESTABLISHED;
- PERSONS STUDY UNDER GENERAL EDUCATION OR VOCATIONAL TRAINING PROGRAMME OR STUDY AT AN INSTITUTION OF HIGHER EDUCATION, BUT NOT OLDER THAN 24 YEARS OF AGE.
- PREGNANT WOMEN WITH 70 DAYS REMAINED UNTIL CHILDBIRTH AND WOMEN RAISING A CHILD UNDER 3 YEARS OF AGE ARE NOT REQUIRED TO REGISTER WITH LE;
- ONE OF THE PARENTS INCAPABLE OF TAKING CARE OF THE CHILD UNDER 8 YEARS OF AGE BECAUSE OF AN ILLNESS, DISABILITY, IMPOSED SENTENCE OR OTHER REASONS, AND FARMS THE ACREAGE OF NOT LESS THAN 2 HA, WHICH BELONGS TO COHABITANTS BY THE RIGHT OF OWNERSHIP OR ON OTHER GROUNDS

PROCESS OF EVALUATION OF APPLICATIONS FOR ASSISTANCE

- A PERSON ADDRESSES A SOCIAL WORKER OF A WARD AND COMPLETES AN APPLICATION OF AN ESTABLISHED FORM;
- THE SOCIAL WORKER WORKING IN THE WARD COLLECTS ADDITIONAL DATA, DOCUMENTS, VERIFIES THEM AND SUBMITS TO A SPECIALIST OF THE DIVISION OF SOCIAL BENEFITS;
- THE SPECIALIST OF SOCIAL BENEFITS VERIFIES THE DATA THROUGH THE INFORMATION SYSTEM OF SOCIAL BENEFITS TO FAMILIES (SPIS), ESTABLISHES THE RIGHT TO THE BENEFITS, CALCULATES THE AMOUNT OF THE BENEFIT, PREPARES THE DRAFT OF THE DECISION REGARDING AWARD OF THE BENEFIT AND SUBMITS IT TO THE HEAD OF THE SUBDIVISION OF SOCIAL BENEFITS;
- THE HEAD OF THE SUBDIVISION EVALUATES ALL THE CRITERIA, VERIFIES WHETHER THE AMOUT OF THE BENEFIT IS CALCULATED PROPERLY AND, HAVING SIGNED THE DRAFT DECISION, SUBMITS IT FOR SIGNATURE TO THE HEAD OF THE DIVISION.

PREVENTION

- THE LAW SPECIFIES THE CONDITIONS WHEN PERSONS ARE NOT ENTITLED TO ASSISTANCE
- IN CASE SUSPISIONS REGARDING ABUSE OF SOCIAL ASSISTANCE ARISE, A SOCIAL WORKER IN THE WARD VISITS THE PERSON (THE FAMILY) AND PRODUCES AN ACT OF HOUSEHOLD AND LIVING CONDITIONS;
- SOCIAL SPECIALISTS COOPERATE WITH THE POLICE, CHILD'S RIGHTS PROTECTION INSTITUTIONS, HEALTH CARE INSTITUTIONS, LABOUR INSPECTION AND OTHER INSTITUTIONS;
- COMMISSIONS ON SOCIAL ASSISTANCE OPERATE UNDER WARDS. THESE COMMISSIONS PROVIDE RECOMMENDATIONS REGARDING OF ASSISTANCE.
